

## **Tuition Scholarship Information Sheet**

2024-2025 School Year

The application period for PreKindergarten-8<sup>th</sup> grade families applying for a tuition scholarship at St. Benedict Cathedral School is now open. The income guidelines are listed below.

St. Benedict Cathedral School is an approved Indiana School Choice Scholarship participant. The Choice Scholarship is an award from the state in which the per student state funding is granted to the approved private or parochial school of your choice. We also can award tax credit scholarships (SGO's) and we have other scholarships available for our students from endowments and other generous donors who support Catholic education.

We look forward to helping you get the tuition support you need through these programs. Please return the application form to us as soon as possible so we can process your application and notify you of the scholarship amount that your child qualifies for. In addition to this form, please include page(s) 1 & 2 of your 2023 tax return showing your adjusted gross income (AGI) and dependents. Please note if you are divorced and/or receiving child support or other income not documented on your tax return, you must include the divorce decree and the amount of payments received in 2023 on the application, along with documentation.

## If your household income falls within these guidelines, St. Benedict Cathedral will be able to assist you with your tuition through an Indiana School Choice Scholarship, an SGO Scholarship, or a St. Benedict Financial Aid.
